#### Greetings from the Adult Education Office Patricia S. Terry, Ph.D.—State Director

Welcome to a new year and a new look for *Adult Education Matters,* the California Department of Education's (CDE) Adult Education newsletter designed to inform California's adult school community. The year 2013 promises to be one of anticipation and challenges for adult schools and adult learners. Our adult community needs to work together to address these challenges while continuing to provide appropriate educational services for our adult learners. We at the Adult Education Office (AEO) renew our pledge to work toward fulfilling the mission of adult education in California.



#### Implementation Guide Survey

The AEO invited agencies to participate in a survey to obtain a baseline of activity with respect to the action items in the *Implementation Guide*. Having this information aggregated at the state level will help to inform work in the AEO and will further support our participation with other stakeholders. The survey tool provided agencies an opportunity to rate the degree to which they have actualized an item. The AEO encouraged the field to collaborate with staff in preparing the agency's response. Responses will not be publicized with names of individuals nor by agency. The survey was due January 31, 2013.

#### Field Partnership Team

The Field Partnership Team met on December 6, 2012, at the offices of the American Institutes of Research in Sacramento, California. Meeting highlights included a discussion of the Implementation Guide Survey, a question-answer session with the CDE administrator in charge of General Educational Development (GED) testing, Diane Hernandez, a discussion with Coordinated Student Support and Adult Education Director, Gordon Jackson, and a discussion with Association of California School Administrators legislative advocate, Adonai Mack, concerning weighted student formula. The next meeting is scheduled for March 6, 2013.

#### New Adult Education Office Changes

The AEO is pleased to welcome aboard two new consultants: David Stang and Dr. Carmen Martinez-Calderon. They will oversee activities in Region 3 and Region 7, respectively.

Dr. Don Taylor, formerly Region 5 consultant, has left the AEO and is now the Administrator in the After School Division. Dr. Martinez-Calderon will oversee Region 5 activities on an interim basis.

#### Governor Jerry Brown's Budget Proposal

Governor Brown introduced his budget proposal for fiscal year 2013–14 on January 10, 2013. The proposal outlines specific changes to adult education. To create a more accountable and centralized adult education system, the Governor proposes \$300 million in new Proposition 98 General Fund revenues to fund a comparable kindergarten through grade twelve adult education system within the community college system.

The AEO and CDE are currently engaged in ongoing discussions regarding the Governor's proposal.

#### New Voters Page

Recently, the Secretary of State introduced a New Voters Web page located at <u>http://www.sos.ca.gov/elections/new-voter/</u>. The page was created to help people who are new to voting or who will soon become eligible to vote, to find basic voting information and materials. The Secretary of State's office presents adult learners with instant access to voting-related resources in English and nine additional languages.

#### Workforce Investment Act, Title II Notes...

The 2012–13 program year continues to bring changes to the WIA, Title II Grant Program.

One change in effect for the current program year involves new National Reporting System (NRS) reporting requirements. Another development is that the open competition for the WIA, Title II grant funds has been postponed until 2014–15. Currently funded agencies will use AEO's re-application process for the 2013–14 year.

#### Office of Vocational and Adult Education

The AEO is gearing up for a monitoring visit from the Office of Vocational and Adult Education (OVAE) regarding WIA, Title II program implementation. The visit is scheduled for the week of March 18<sup>th</sup>.

The 2011–12 WIA Annual Report was submitted to OVAE by the December 31, 2012, deadline. The report will be available on the CASAS Web site.

The 2013 Winter Consortium was videotaped on January 15, 2013. The videotape, which includes a presentation on data from WIA, Title II agencies and panel discussion on student transition strategies, will be available on the CASAS Web site.

And finally, currently funded agencies should note that the accountability and implementation trainings provided by CASAS should have been completed by January 31, 2013.
