Periods of Participation (PoPs) are represented by Columns K-O.

- Periods of Participation denote multiple periods of enrollment by the same student
- If a student returns, and has more than 90 days since the last date of participation, then a new PoP must be created for that student.
- Enrollment, instructional hours, and pre/post-testing are all separated by each PoP.
- Columns L-O record outcomes and percentages by PoP, rather than by individual student.

# PoPs –Reminder of Policy

---

- ▶ A Period of Participation (PoP) begins when an individual enters the program.
- ▶ A PoP ends at program exit (90 days without service and no scheduled services).
- ▶ A PoP *does not* end when a program year ends.



# PoPs –Implications

## Participant Status

---


1. An individual becomes a participant once he/she has attained 12 hours of instruction within a period of participation (PoP).
2. Participant status is retained until an exit occurs.
3. Individuals must achieve participant status each time a new PoP begins.



# PoPs –Implications

## Participant Status (continued)

---

- 
- 4. Participants who remain continuously enrolled across multiple program years do not need to requalify as a participant in new program years.
  - 5. Measurable Skill Gain (MSG) is reported at least once for every participant per program year.


