## NEDP UPDATES

### NEDP AGENCY MAINTENANCE FEE



**The annual NEDP maintenance fee will be increasing to \$1,200 for Program Year 2024-25.**

This change is outlined in the administrative notice dated January 31, 2024, which can be found on the NEDP Professionals page.

Please note this updated fee will be invoiced in August. If your agency wishes to make an advance payment using available funds from this year's budget, we encourage you to do so.

### NEDP WEB ENROLLMENT UNIT (WEU)



Effective July 1, 2024, there will be an increase in the cost of Web Enrollment Units (WEUs), including both diagnostic and generalized assessments. This change is in accordance with the administrative notice issued on January 31, 2024, and is accessible on the NEDP Professionals page.

The new cost for each WEU will be \$75. It is important to note the WEUs do not have an expiration date. Any units purchased prior to July 1, 2024, will be priced at the current rate of \$60 each.

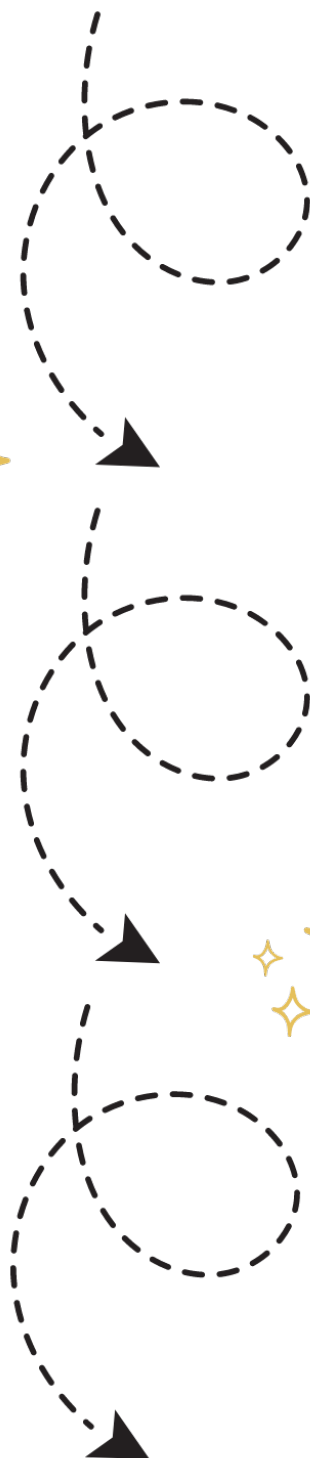

# NEDP GENERALIZED ASSESSMENT ORDER OF ASSESSMENT



## 1 Client completes

activities within a competency area or a set of Post-Task Assessments (PTA) within 1-2 weeks and submits activities to assessor



## 2 Assessor evaluates & releases results

within 1 week of submission, providing procedural feedback and referring client to tutorials or outside resources when necessary



## 3 Client & assessor schedule IOC

within 2 weeks of releasing activity results



## 4 Between results & IOC

Client is encouraged to reattempt items & seek remediation when needed



## 5 IOC is conducted

PTA and Portfolio Review continue as usual



## 6 As of April 24, 2024

New NEDP staff and agencies will be trained to conduct NEDP with a formative assessment between activity completion and the In-Office Check
