YOU ASKED...WE ANSWERED

Q: Can Math GOALS 2 be used for NEDP diagnostics? If so, what's the required cut score?

A: Yes! Math GOALS 2 may be used for NEDP diagnostics. Math GOALS level D (forms 927 and 928) and level E (forms 929 and 930) may result in a scale score of 226 or higher, which is the required math cut score regardless of the CASAS test series. 
NEDP FAQ

WHAT HAPPENS WHEN A CLIENT MOVES?

Clients may transfer from one agency to another with the approval of **both agencies**.

Transfer Process

- 1. Both agencies must approve the transfer
- 2. Send a request for transfer to nedp@casas.org with both agencies included on the email
- 3. Once CASAS receives approval from both agencies, the client will be transferred



Update the original advisor, new assessor and new reviewer fields

If the client is not currently active

- Follow the diagnostic guidelines for clients who have been inactive
- Remove the Date Exited on the Outcome Data screen
- · Make sure the "login disabled" box is unchecked
- Regenerate the client's password
