"Grantees must not use federal funds under this project in any manner that violates the United States Constitution, Title VI or Title VII of the Civil Rights Act of 1964, Title IX of the Education Amendments of 1972, section 504 of the Rehabilitation Act, the Age Discrimination Act of 1975, Title II of the Americans with Disabilities Act of 1990, the Boy Scouts of America Equal Access Act of 2001, section 117 of the Higher Education Act of 1965, as amended, or other applicable federal law."

The Department also intends to conduct reviews of grantees' use of funds to ensure ongoing compliance with the above provisions and all other applicable laws and regulations."

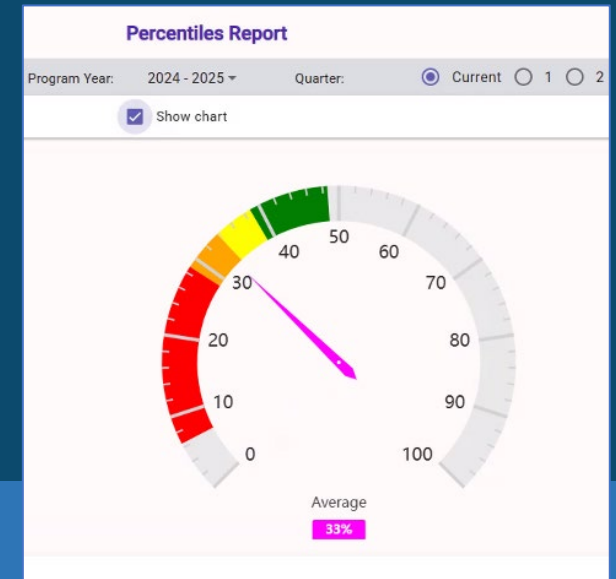

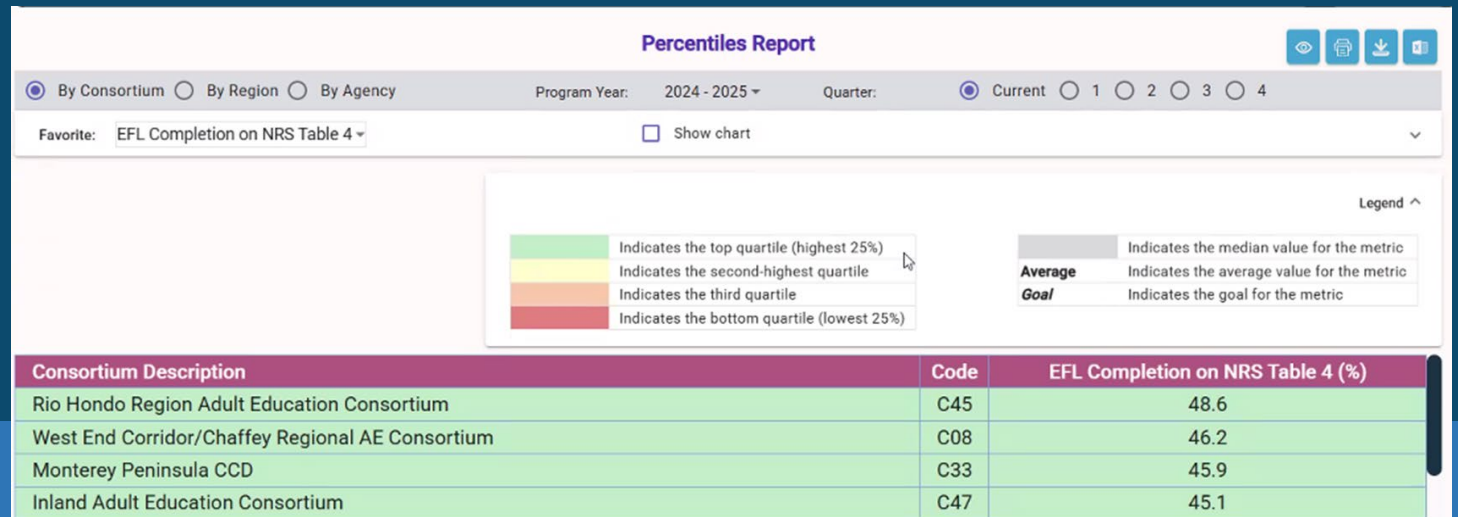
