




1Q Comparison: WIOA II Enrollment



- Mark **Employed with notice** only for students with an established last day of employment.
- Mark ***Not in labor force*** only for students with “official” reasons such as incarceration, military, or long-term hospitalization.

Labor Force Status (2)

Labor Force Status and Goal Setting

- Distinguish students looking for work vs. those not looking for work by marking Goal of ***Get a Job***.
- Mark Get a Job only for students actively looking for work.

Co-Teaching vs. Alternate Teaching in TE

- For IET classes using Co-Teaching models (such as “iBest”) you can designate both programs for one Class Instance in TE
- For Alternate Teaching models, you should create separate Class Instance records (usually one for the CTE class and one for ESL.)
