

Follow up Reporting (3)

Statewide Data Review:

- CDE and CASAS did three tech assist sessions in late March – for large, medium, and small agencies
- Most "rank and file agencies" at or above state average
- Small but substantial group of large to very large agencies below state average
- Many small agencies still getting on board with the basic follow up requirements

- Overall, older, and female respond more often to the survey.
- Will compare data between ABE/ASE and ESL students.

Follow up Reporting (5)

- Overall, native Englishspeaking students responded less often than students of other languages.
- Will compare ABE/ASE and ESL data.
- Not enough data to compare languages outside of English and Spanish; and potential "agency bias"

- Individualized Taxpayer ID Numbers (ITIN) are now authorized for the California EDD data match.
- ITIN numbers have the same 9 digit format as SSN, and begin with the number 9. *9xx-xx-xxxx*
- TE will add a new field for this ID number.

WIOA II Program Implementation Survey (1)


- 96.7% of agencies have established local level performance goals for AEFLA funded programs.
- 88.6% of agencies reported established process to transition students from ABE/ASE/ESL classes into postsecondary education (CAEP partners, For Credit Degree Programs, and Postsecondary Programs such as CTE).
- 82.4% of agencies reported having an established process to transition students from ABE/ASE/ESL classes into the workforce and/or job training.
- 77.5% of agencies interacted with a local America's Job Center of California (AJCC) in this program year.





TE Teacher Portal

- The Teacher Portal is an easy-to-use, web-based tool for teachers,
- Provides intuitive, colorful user interface to view class data.
- Generate reports for selected students and classes, review demographic data, and take class attendance!



TE Features (4)

Proxy Wizard

- The TE Proxy Wizard resumes a "regular" proxy date range in 2023.
- Tests administered May 1, 2023 or later can be proxied with a date of July 1 to serve as the pretest for PY 2023-24.
- For PY 2023-24: ensure that any proxied test is from the same CASAS test series and modality as the tests administered in the new year.




Strengths of the New System


