- HyFlex instruction model can result in positive outcomes for student performance.
- Students have a positive response to the HyFlex instructional model.
- HyFlex instructional model removes barriers to student participation.





Transitioning to the new test series

- Many programs are choosing to switch to the new test series to pre-test students for the upcoming school year
- Prior to switching, please confirm that your state has updated its assessment policy for the new series. While CASAS does not require any verification of an updated assessment policy, agencies will not be able to use the new CASAS assessments for reporting purposes until the state policy has been updated.
- Your program has two options:
 - Adjust your current ABE and ESL testing sessions to administer the new series
 - OR have a new set of session added (ABE GOALS, ESL STEPS) to administer the new testing sessions and the old test series
- Your program may want to keep a post-testing session to post-test students on the old test series IF they have 10+ instructional hours

Best Practices for Testing Sessions

- Use the same testing sessions for the whole program year.
- Use a standard set of testing sessions for each separate site.
- Make sure each testing session is labelled clearly and correctly.
- Remove testing sessions (by deleting or expiring) that are incorrect or no longer used.

- CASAS is pleased to announce a security upgrade for CASAS eTests.
- CASAS eTests is now integrated with the Microsoft Windows[™] test kiosk feature called "Take a Test."
- There is no installation necessary for Take a Test because it is built into Windows.

- Supports new accommodation features in CASAS eTests




