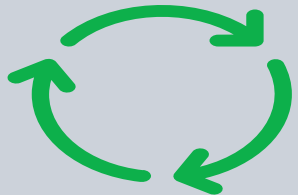

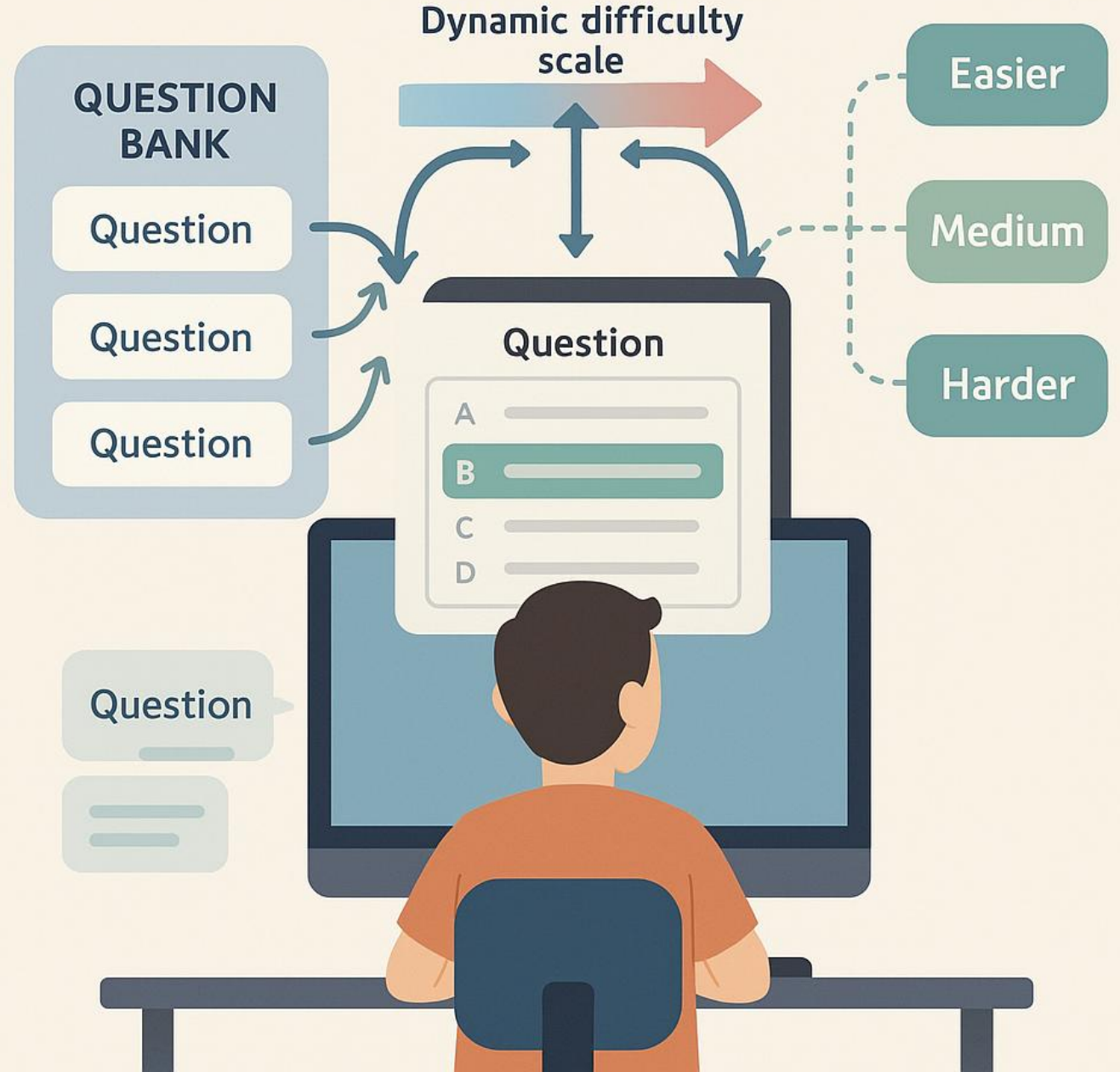

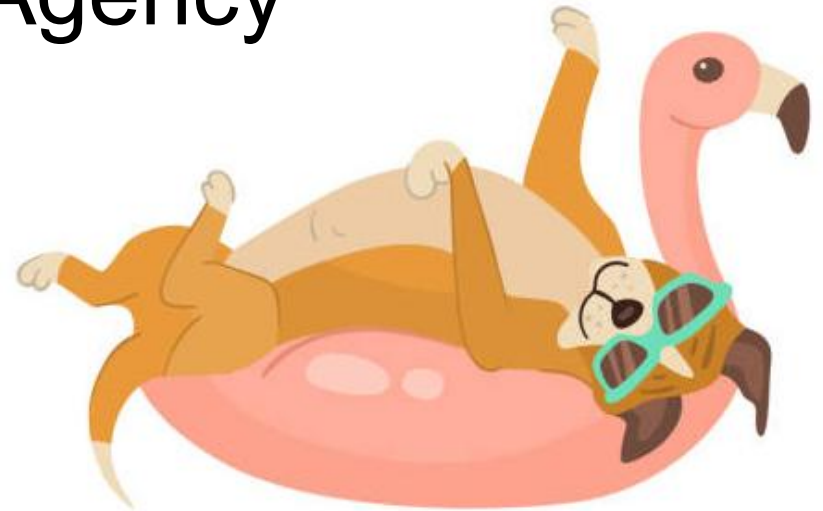


- Uniform CASAS pre-/post-test policy for California WIOA II learners
- Recommendations for when to test students with multiple Periods of Participation (PoPs)
- Placement testing for all learners upon enrollment
- Minimum 40 hours requirement between pre- and post-tests
- Policy for assessing and reporting distance learners
- Guidelines for implementing local assessment

- WIOA Title II agencies must develop and implement a Local Agency Assessment Policy, and update it annually.
- Local agencies may develop their own local assessment policy guidelines but must address all state level policy in the Local Agency Assessment template.



- Establish procedure for appropriate instructional placement, and pre- and post-testing
- Maintain a calendar of the year's test dates, with specific “testing dates” and make up days for those who are absent
- Specify test security precautions and uniform test administration procedures for all programs
- Identify preferred test series and modalities, and effective strategies for using assessment results to inform instruction
- Authorize test accommodations for learners with disabilities



- Specify recommended hours between tests for each program, including exceptions to 40 hours rule and procedure for approving them
- Ensure that all personnel are trained on CASAS testing procedures
- Relate assessment selection and instructional strategies to defined regional priorities and note assessment collaboration with regional partners



- Define procedures for hours and assessment for special programs such as EL Civics, IET, and Distance Learning

- Agency is not limited to issues included in the Local Assessment Policy template.

Examples of issues to address:

- Additional agency security issues
- Accommodations for disabilities
- IET/IELCE
- Information about specific eTests or pencil/paper process, such as “checklists”
- Agreements with regional partners, such as WIOA Title I, neighboring schools, local employers
- Distance Learning/Remote Testing

Populating Listers in the New Program Year

All TE Listers have embedded default filters that only show data with activity in the current program year.

Since this is a new program year, don't forget to switch the filter to the prior program year to view data.

This is usually done at the beginning of the new program year.

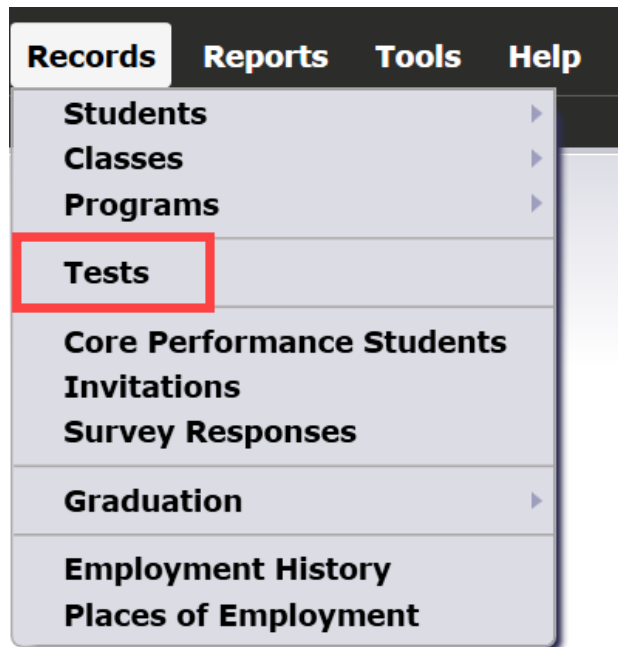

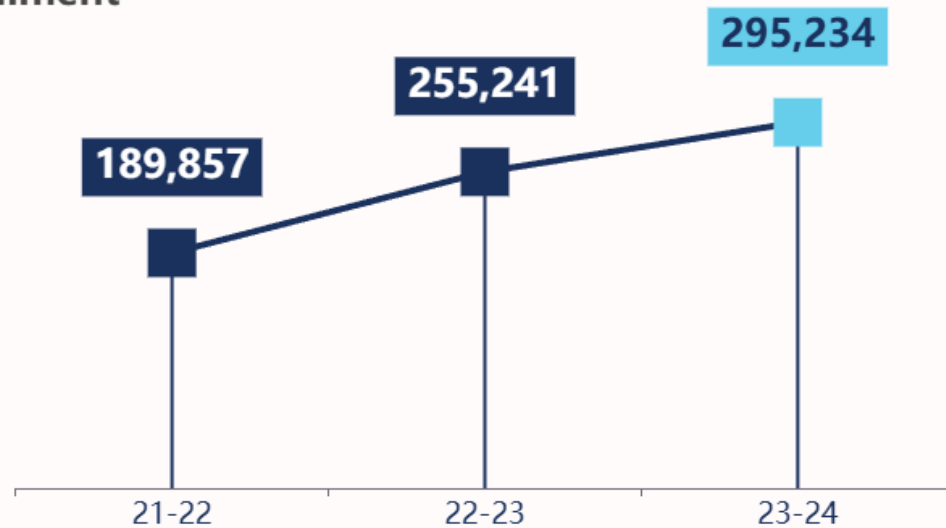

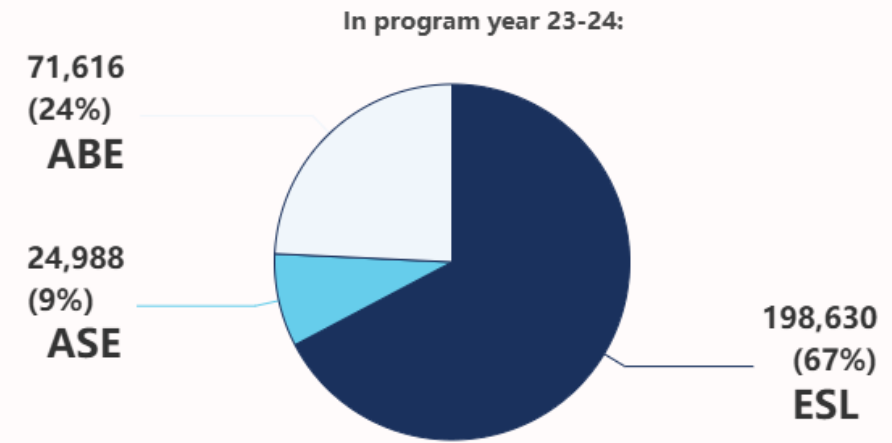

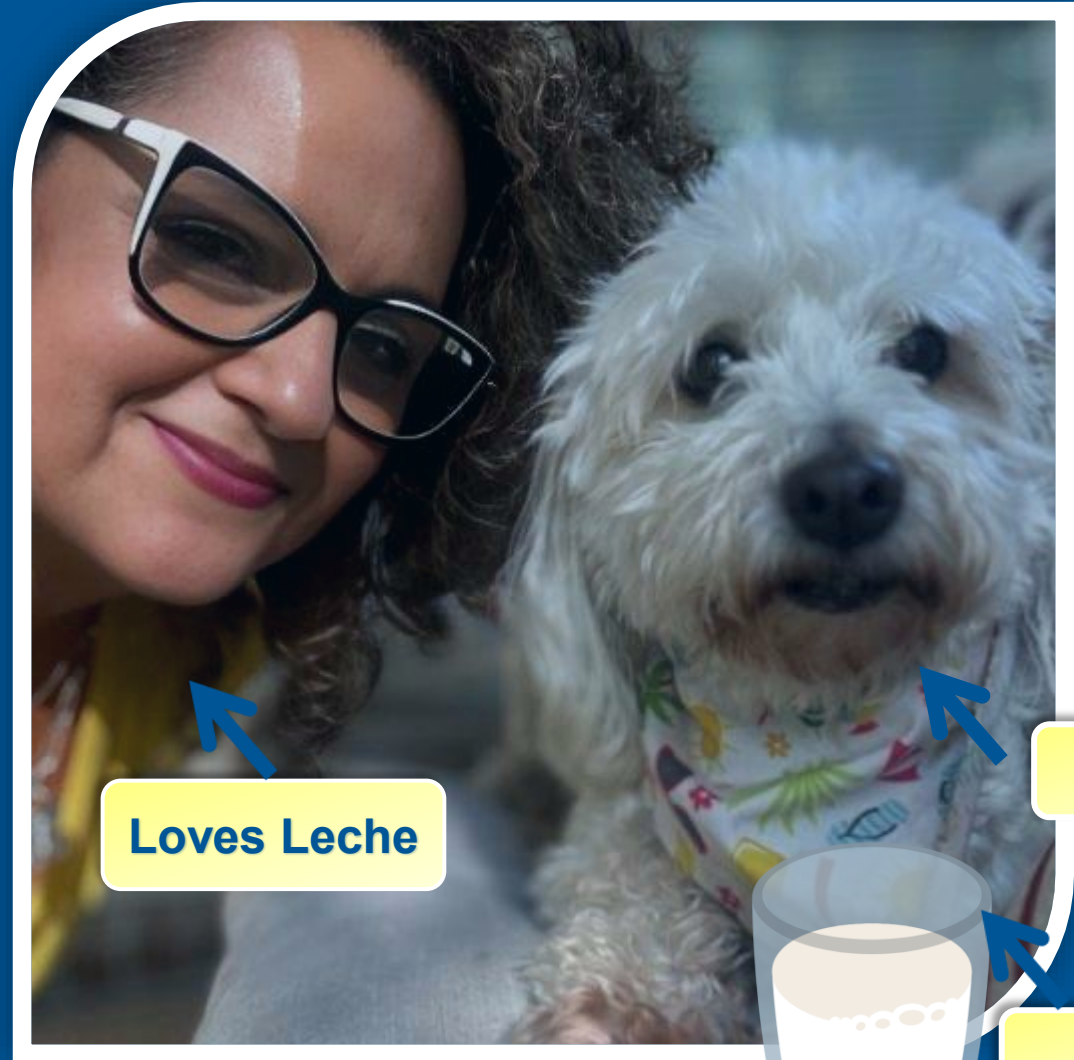
Enrollment by Program

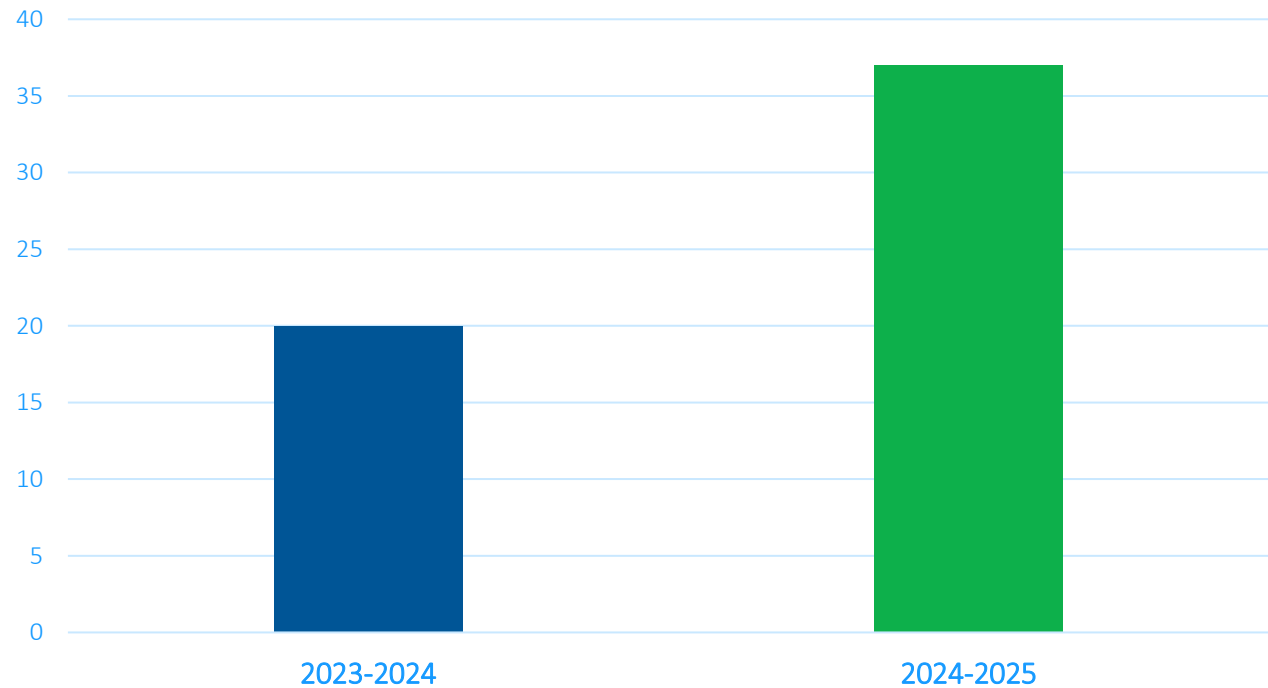


TEACHER PORTAL: Growth by Number of States

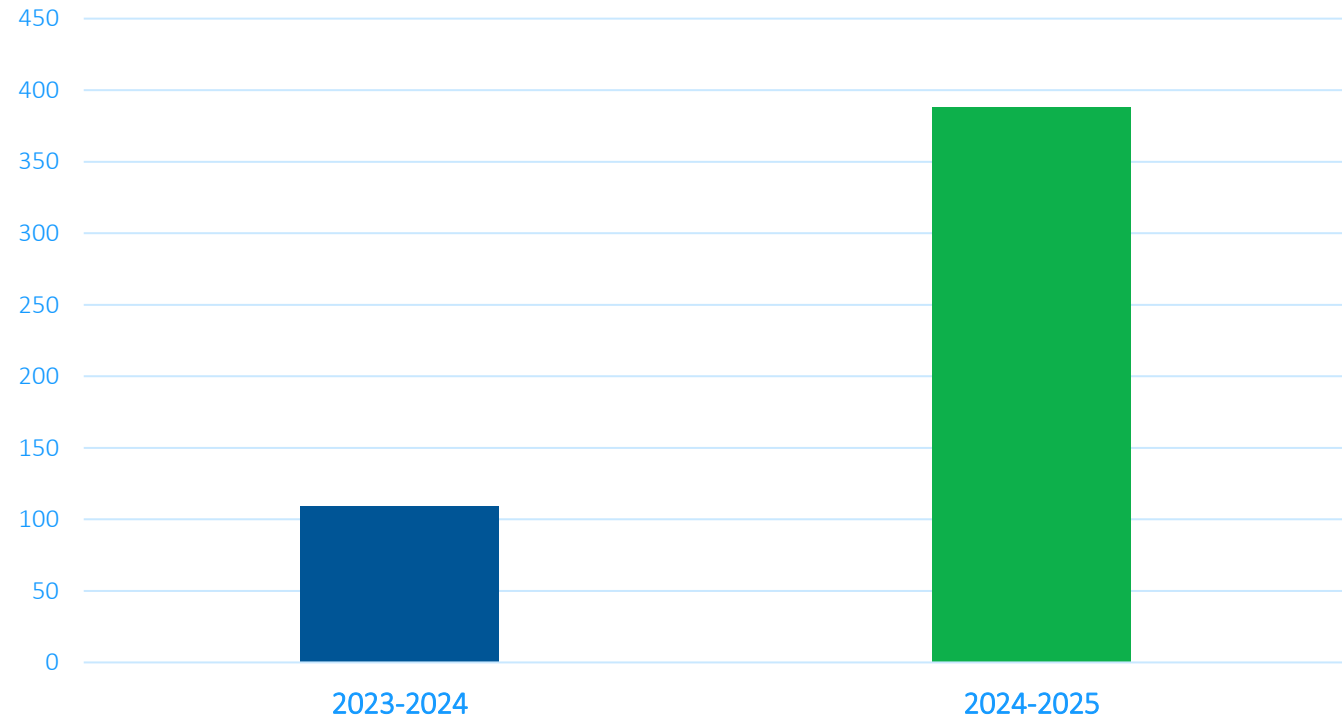


TEACHER PORTAL: Growth by Number of Agencies

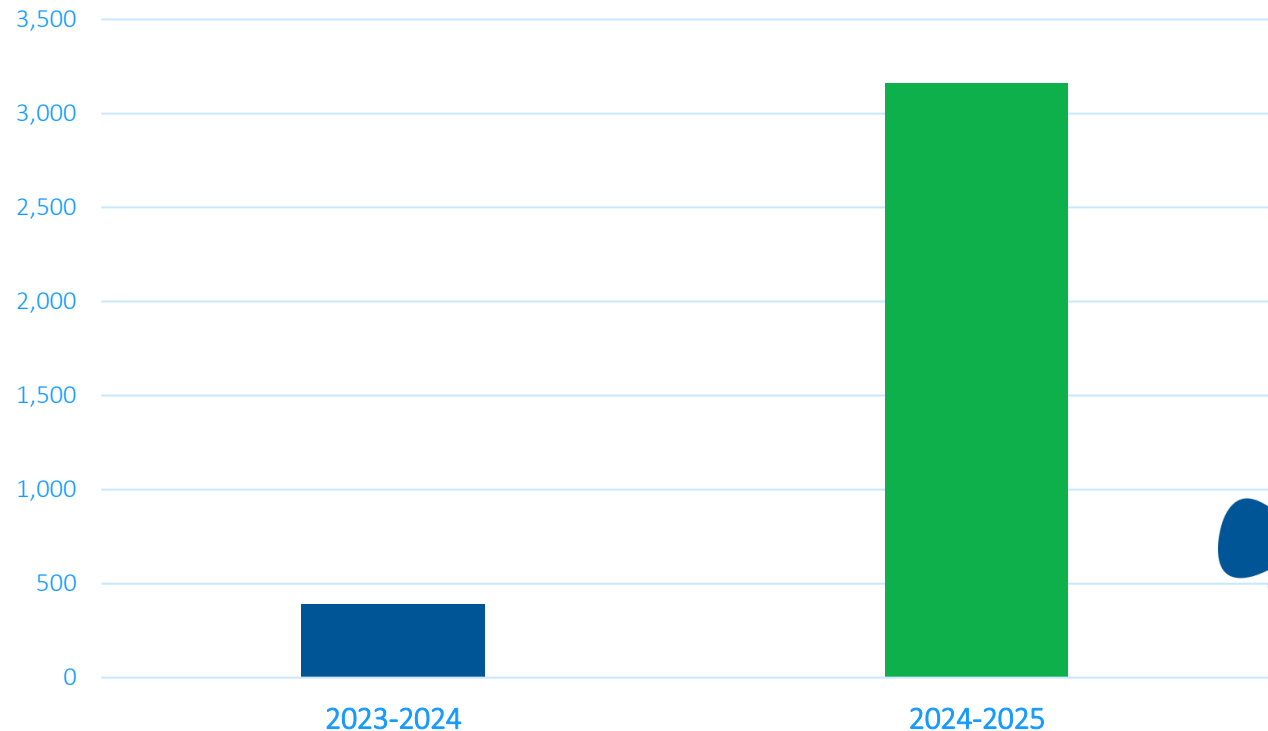

Remote Testing Myths

- #1 – Station Registration Code will not appear unless the Proctor starts a Remote Testing Session on eTests.

Incorrect!

The Station Registration Code will appear for both in-person and remote testing sessions.



Remote Testing Myths

- #2 – The Proctor cannot remote test the student without viewing their full screen.

Incorrect!

Similar to in-person testing, the proctor must view the test taker (with camera and audio) and can monitor progress via eTests.



Remote Testing Myths

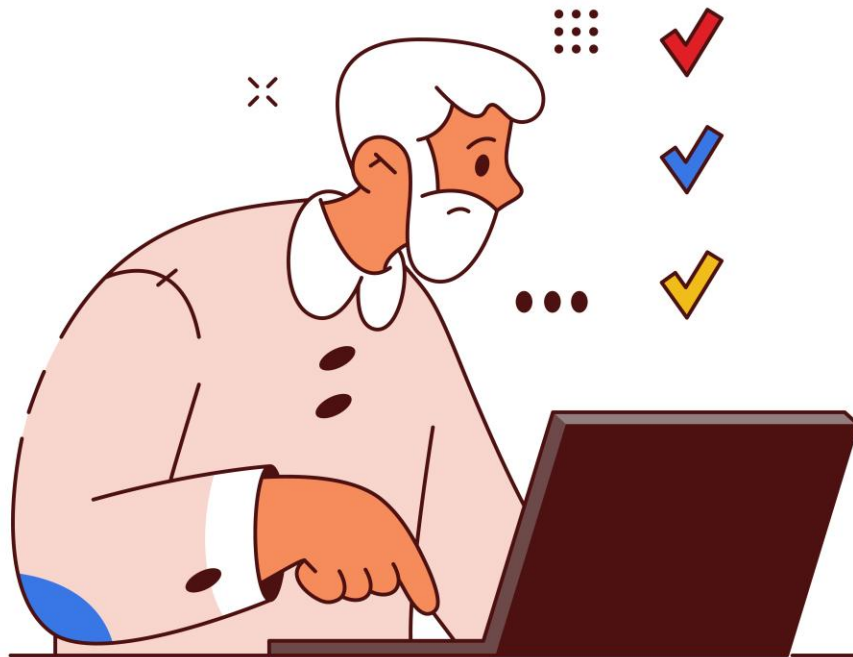
- #3 – Proctors can only test one student at time.

Incorrect!

CASAS Remote Testing Policy allows one proctor to test up to 15 students at a time.

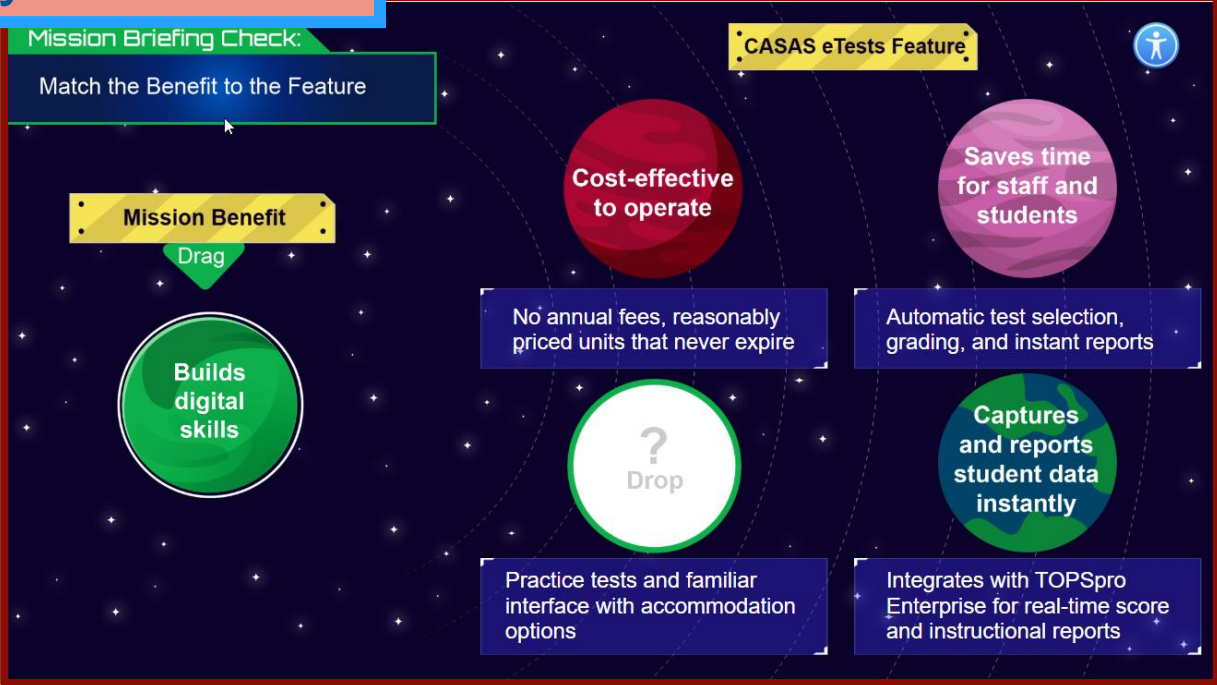
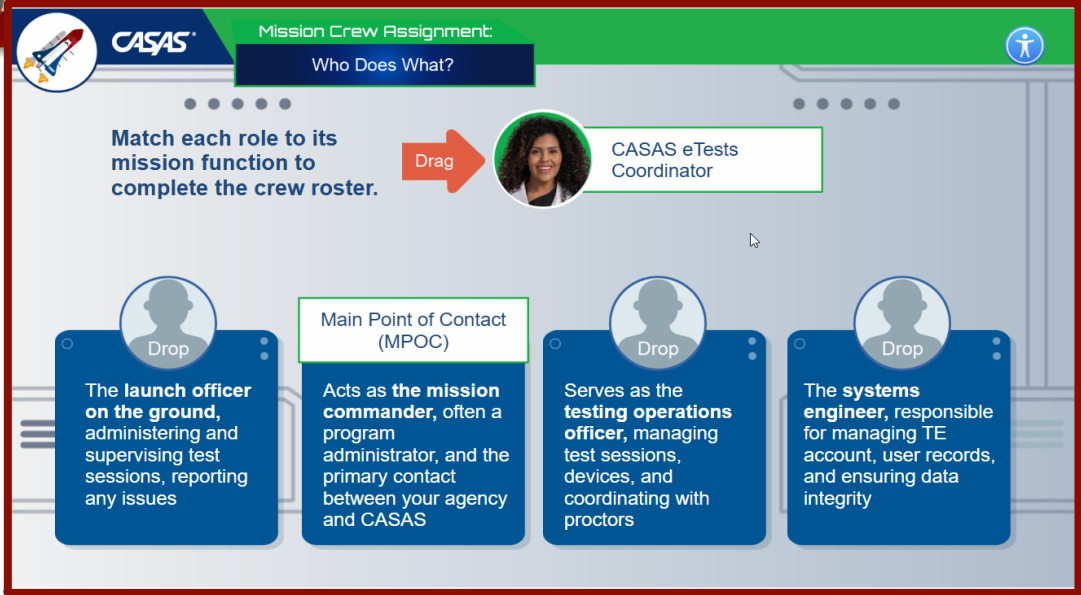
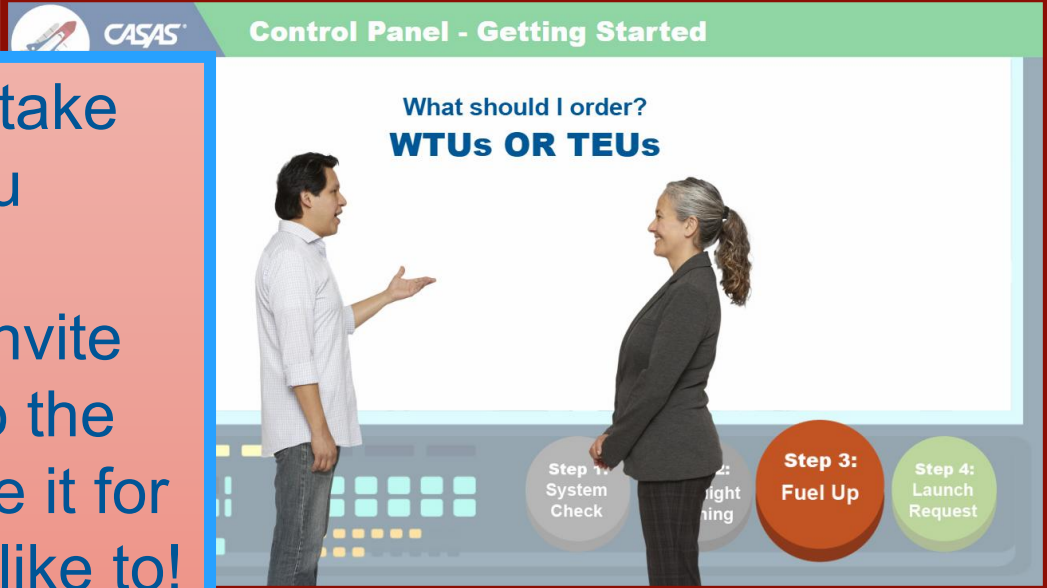
